

Application Process and Annual Fees

Application Process

Our user-friendly application process consists of:

- Downloading and completing the IAC Association Membership Application Form (20 minutes approx.)
- Scanning the completed application form and emailing it to IAC attaching any supplementary information.
- Paying the relevant membership fee (see below) by Bank Transfer.

The downloadable Membership Application Form contains two sections (A & B).

Section A: Basic Contact Information (Association name, details, contact person, email address, website, etc.) Section B: Association Details: These include your Association's Aims, History, Pre-existing local/regional certification (if any), Ethical code and Values. NB: In order to make membership more affordable to Associations in economically developing countries, the annual fees are based on the World Bank GNI - Atlas Method Data The World Bank use four income categories (Low, Middle, Upper Middle, and Upper) to define a country's 'income level'. IAC consider countries within the first two category classifications (Low and Middle income) to be 'economically developing' countries and should pay the second fee structure, World Economic Area 2 – above). IAC is a non-profit organisation and we attempt to keep Association membership fees to a minimum. Membership income contributes towards our operational and developmental costs. Fees above relate to Spring 2017.
