### FEE CATEGORIES

IAC is a non-profit organization and we seek to keep fees low per individual member. Membership income contributes to operating costs and developing the profession worldwide. Payment categories are based on scale (member numbers), region, and benefits. In order to make membership more affordable to associations in developing (non-high-income economy) countries, fees are based on the World Bank GNI - Atlas Method data. Fees relate to 2023.

Non-High-Income Economy Countries: All countries that are high-income economies - as designated by the World Bank index - are listed at the bottom of this page). If a country is not listed then it is presently considered to be a non-high-income economy country.

**Multi-Year Plans:** In certain circumstances a discounted multi-year arrangement may be put in place. Please contact us for details.

## **APPLICATION & MEMBERSHIP PROCESS**

Associations must be IAC Association Members at Level 2 or Level 3.

- Associations complete the Application Form.
- Application is reviewed and approved.
- Memberships commencement date is agreed with associations.

- Fee category payment is completed and memberships begin.
- An IAC 'Certificate of Membership' template will be issued to the association's named contact and disseminated by the national association to your members. Certificates can be customised to include both associations' logos.
- Monthly e-newsletters will be sent to the association's named contact and disseminated by the national association to their members.

#### TERMS AND CONDITIONS

- IAC membership is available only to persons over 18.
- IAC membership and benefits can only be used by the agreed individual national association members.
- Voting rights and IJAC Journal access are not included.
- Membership is not a form of authentication (verification, credentialing, accreditation, or approval) of qualifications or practice quality. IAC does not verify qualifications and relies on the national association/organization structures to do so.
- Membership benefits are only available to groups and individuals whose membership is current and paid in full.
- The IAC name and logo must be removed from all electronic materials (e.g., websites and online brochures) as soon as membership expires.
- IAC reserves the right to change the membership fee having given reasonable advance notice.
- IAC will not have any liability arising out of national association/organizations members' actions.
