What is Advocacy? Advocacy is activity that aims to influence decision-making in political, institutional and social systems. It brings a much-needed voice for the counselling profession. Advocacy takes place at local, national and international level.

Why is advocacy important? Advocacy enhances the reputation and credibility of the profession and allows us to strengthen the position of counselling by influencing counselling-related policy worldwide. Important, high-level policy decisions on mental health, education, social issues, and work, are made at the intergovernmental level (e.g. WHO and UNESCO) and it is essential to ensure the appropriate inclusion of counselling......continue reading HERE.
