#### **Bill Borgen**

#### **Candidate for IAC President**

Since its inception in 1966 the International Association for Counselling has been a key international catalyst in the development and enhancement of contextually and culturally relevant counselling research, education and services around the world. I have been involved in a leadership capacity with IAC since 1990, and was President from 1998 to 2006. Over that time there has been continuity in the mission and objectives of the association, and an ongoing evolution and how our work is accomplished that has been heavily influenced by rapidly developing and increasingly accessible technologies. Over the past six years a number of initiatives have enhanced the profile and reach of the association. These include the creation of round tables on relevant issues and populations, regional representation of members of the Executive Council, more direct links with national and regional counselling associations, the appointment of a CEO, the strengthening of connections with UNESCO and the World Health Organization, more flexible ways to become a member, and the world mapping project.

I believe that IAC is poised to move forward with increased engagement by counsellor educators, researchers, educational institutions, national and regional associations, government and United Nations agencies, and individual members from around the world. Increased use of digital technology and social media, along with ongoing in person exchanges, and increasing levels of infrastructure support for our regional representatives, will strengthen the funding base of association and enhance IAC's ability to engage in its core mandate of promoting and advancing the creation and re-development of counselling research, education, and practice globally. I look forward to the opportunity to work with the Association in building on and extending the initiatives that have been undertaken, and in moving forward with new endeavors to enhance the profession of counselling.



#### **Blythe Shepard**

#### **Candidate for IAC Treasurer**

I am a Canadian of British and Indigenous (Mohawk) ancestry. I obtained my PhD in 2002 in Educational Psychology with a speciality in counselling psychology from the University of Victoria, British Columbia. Currently I am a full professor in counselling psychology at the University of Lethbridge in Alberta. I am an active member of the Canadian Counselling and Psychotherapy Association (CCPA) and have gained the experience and expertise necessary to promote the profession and its contribution to the mental health and well-being of all. My experience within CCPA includes: four years as a national Board member, six years as an Executive Committee member (four years as National Treasurer), four years as Chair of the Certification Committee, and three years as co-chair of the Inter-Provincial Mobility for the Counselling Profession project. I have been very involved in the regulation of the counselling/psychotherapy in Canada: as a member of the BC Task Group for the Regulation of Counselling and a co-developer of the entry to practice competencies for the profession (2006) and the revised edition (2016); as President of the Counsellor Educators and Supervisors Chapter (2018-2019) and a member of the The Federation of Associations for Counselling Therapists in BC (FACTBC). Recognizing that clinical supervision is an essential component of ongoing

professional development, I have been instrumental in creating the national Canadian Certified Counsellor-Supervisor Certificate (CCC-S); in developing and instructing a graduate course in supervision sponsored by CCPA; in co-authoring Supervision of Counselling and Psychotherapy: A handbook for Canadian Certified Supervisors and Applicants; co-editing the textbook, Supervision of the Canadian Counselling and Psychotherapy Profession; and co-editing the newly revised Canadian Counseling and Psychotherapy Experience: Ethics-Based Issues and Cases and the revised CCPA Standards of Practice. I currently the IAC Treasurer and I also chair the IAC Indigenous Roundtable. Promoting the profession of counselling/psychotherapy has been my life focus for many years in Canada and I am excited to continue to engage in international initiatives headed by the International Association for Counselling.
